Notice of Filing of Assignment and Bar Date for Submission of Proofs of Claim

To whom it may concern:

As you may be aware, Snake River Spirits, Inc. has ceased business operations and determined that it is in its and its creditors' best interests to liquidate its assets. To accomplish the liquidation, on June 25, 2021, Snake River Spirits, Inc. (the "Assignor") and SRS ABC, LLC (the "Assignee") executed an Assignment for the Benefit of Creditors. The Assignment has been filed with the Chancery Court of the State of Delaware, as Case No. 2021-0559.

You are in receipt of this Notice because you have been identified as a potential creditor of the Assignor or an otherwise interested party.

In compliance with the Assignment, the Assignor has assigned all of its assets to the Assignee. Assignor's brands included Zodiac Vodka and Horizon Gin, and the assets assigned to Assignee include primarily inventory and intellectual property (the "Assets"). Assignee is in the process of determining the best method to market and sell the Assets. Once the Assignee has sold the Assets, and if there are sufficient funds left over after the payment of the Assignee's administrative expenses, amounts owed to properly perfected secured creditors, and priority claims of the federal or applicable state governments, it will then distribute available funds upon conclusion of the sale and claims process.

To assert a claim against the Assignor, you must file a proof of claim form. A proof of claim form is enclosed with this Notice. You should attach all documentation that supports your claim to your completed proof of claim form. If you do not provide sufficient evidence of your claim, your claim may be rejected.

Please submit the completed proof of claim form, along with all supporting documents, as stated on the enclosed proof of claim form. Your proof of claim must be received no later than **September 30, 2021, at 5:00 p.m. (Eastern Prevailing Time)** (the

“Bar Date”). If your proof of claim form is not received by the Bar Date, any claim you may have against the Assignor may be barred and you may not receive a distribution if there is a distribution. If your claim is rejected, you will receive notice of such rejection.
