Upon consideration of the *Assignee’s Motion for Entry of Scheduling Order* (the “Motion”) filed by Classic Brands ABC, a Delaware Series Limited Liability Company (“Assignee”), in its sole capacity as assignee for the benefit of creditors of Classic Brands Holdings, LLC, a Delaware limited liability company, Classic Brands Intermediate Holdings, LLC, a Delaware limited liability company, and Classic Brands, LLC, a Delaware limited liability company, and the Court having jurisdiction thereof pursuant to applicable Delaware law, including 10 *Del. C.*

§§ 7381, *et seq.*, being advised of the grounds for the Motion and finding good cause therefor:

**IT IS HEREBY ORDERED that:**

1. The Motion is **GRANTED**.
2. Assignee shall file an inventory and accompanying affidavit with this Court as required by 10 *Del. C.* § 7381 no later than December 27, 2022.
3. Assignee shall file a Motion for the appointment of appraisers as required by 10 *Del. C.* § 7382 with this Court no later than December 27, 2022. Assignee shall file the appraisals with the Court after its receipt of both appraisals.
4. On the date the appraisals are filed with the Court under paragraph 3 of this Order, Assignee shall file with the Court a Motion to approve the Bond required by 10 *Del. C.* § 7383(a).
5. Assignee shall file an account of its activities as Assignee under 10 *Del. C.* § 7385(a) on or before the first anniversary of the date of the Bond, and thereafter on or before the yearly anniversary date of the Bond until this proceeding is closed.
